- vi. Chhungkua a mi tu emaw berin thla khatah cheng singkhat sang nga (Rs. 15,000) a hlawh phak chuan.
- vii. Income tax pe chin.
- viii. Professional tax pe chin.
- ix. Irrigated land acre 2.5 aia zau nei chin.
- x. Unirrigated land acre 5 aia zau nei chin.
